WSF ACCREDITATION TERMS AND CONDITIONS

Connor Squash Flooring System "Squashplay", "Neoshock", "Duracushion II" and "Rezill Sleeper DIN"

This Accreditation renewal is subject to the following terms and conditions:

1. The period of Accreditation will be from 1 January to 31 December 2016 and will be valid in all member countries of the WSF.
2. The Accreditation will apply only to installations where **Connor Squash Flooring System "Squashplay", "Neoshock", "Duracushion II" and "Rezill Sleeper DIN"** have been supplied and installed either by **Connor Sports Flooring** or one of its appointed agents, in accordance with the standard specifications published by **Connor Sports Flooring** and guaranteed in respect of workmanship and materials for a period of not less than **5 years** from the date of hand over to the court owner.
3. **Connor Sports Flooring** shall make it clear in its published sales and other promotional literature that the WSF Accreditation applies only to the use of **Connor Squash Flooring System "Squashplay", "Neoshock", "Duracushion II" and "Rezill Sleeper DIN"** comprising of the above components.
4. The WSF will wish to monitor the performance in use of **Connor Squash Flooring System "Squashplay", "Neoshock", "Duracushion II" and "Rezill Sleeper DIN"** and the company will supply such information as will enable this monitoring to be undertaken. The WSF is considering how a suitable monitoring scheme for all Accredited products will operate. It is likely that the Federation will wish to have regular access to a comprehensive list of the addresses of court complexes in which **Connor Squash Flooring System "Squashplay", "Neoshock", "Duracushion II" and "Rezill Sleeper DIN"** have been installed. The Federation guarantees that any confidential information supplied to it by **Connor Sports Flooring** will not be made available to any competitor of **Connor Sports Flooring** or to any other agency without the prior permission of **Connor Sports Flooring**.
5. During the period of Accreditation, **Connor Sports Flooring** will be entitled:
 - 5.1 To use the standard WSF Accreditation Scheme logo on advertising or promotional material relating to **Connor Squash Flooring System "Squashplay", "Neoshock", "Duracushion II" and "Rezill Sleeper DIN"** and to describe the product as "WSF (or World Squash Federation) Approved and Certified".
 - 5.2 To be included in the list of accredited materials or components which will be published from time to time by the WSF and supplied both to all member countries and any agency requesting details of recommended materials or components for court construction.
 - 5.3 To have a link from the official website of the World Squash Federation to the company's website.
6. Within the three months prior to the end of the period of Accreditation, you may wish to apply to the WSF Operations Manager for renewal of the Accreditation of **Connor Squash Flooring System "Squashplay", "Neoshock", "Duracushion II" and "Rezill Sleeper DIN"**. The WSF shall have sole discretion as to whether this renewal is granted and, in considering an application for renewal, will take into account any facts it considers appropriate. If the WSF decides to renew the Accreditation, it may be subject to such conditions as the WSF sees fit.
7. All correspondence concerning the Accreditation should be addressed in the first instance to the Operations Manager of the WSF.
